## MOST OF THE EEF FUNDED POSITIONS ARE NOT REQUIRED BY THE STATE

They are considered "luxuries." For the 2016-2017 school year, EEF dollars funded positions such as 5th grade teachers, counselors, nurses, special ed, & reading and math specialists at the elementary schools. At the middle and high school levels, the funds helped lower class size levels by funding robotics, gifted and talented and AP teachers, and many more.

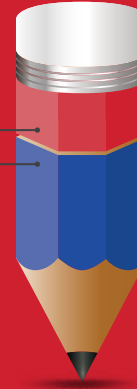
